Mandatory requirements and further information:

- Applications for filming or taking photos on the properties of the Bavarian Palace Administration (Bayerische Schlösserverwaltung – BSV) must be submitted to the Bavarian Palace Administration in writing at least 10 working days in advance. Exceptions to this rule are filming and taking photographs for the daily news reporting.
- Dates for filming and photography projects are only available from Monday until Friday, and for indoor projects usually only outside museum opening hours.
- Film and photo permits are generally subject to a fee. The fee is calculated based on the nature of the project, the time and effort involved in filming and photo shooting and the intended use. Applicants will also be liable for additional costs (e.g. personnel or operating expenses) incurred in the course of the project.
- Filming permits usually include the following scope of rights: broadcasting as often as desired through the TV channel and its subsidiary enterprises or partner channels in German-speaking countries for a period of 3 years (and in case of foreign broadcasters, in the language of the country), publication on the homepage and in social media channels of the broadcasting group.
- In case of photo permits, a printable specimen copy of every photo taken must normally be submitted to the Bavarian Palace Administration for publication free of charge in its own publications and a specimen copy of each publication must be submitted to the Bavarian Palace Administration.
- Express permission is required at all times for driving and parking vehicles on the properties of the Bavarian Palace Administration.
- **The permit is valid only for the specific purpose applied for. Any and all passing on of film and photo material to third parties and any and all use of film and photo material for other purposes requires the prior permission of the BSV.**
- In order to protect the museum rooms, special requirements must be observed during filming and shooting. These set out in the General Terms and Conditions for Photo, Film and Television Shooting and are part of the contract.
- Data protection notice: We treat your personal data confidentially and in accordance with statutory data protection regulations as well as the data protection declaration of the Bavarian Palace Administration, which you can access on the Internet at <https://www.schloesser.bayern.de/deutsch/service/impress/impress.htm#datenschutz> . Your information, including the contact details you provide, will be stored by us in order to process your inquiry and provide our services until you request us to delete it, revoke your consent to store it, or the purpose for storing the data no longer applies. Mandatory legal provisions - in particular retention periods - remain unaffected.
